

# Type B Procedure - Conditions

Dear Patient,

Your primary procedure is defined in the *Private Health Insurance (Benefits Requirements) Rules 2011* (the Rules) as a **Type B procedure**.

A Type B procedure is specified as either a Band 1, 2, 3 or 4 and it is deemed that it is a **Day Only** procedure (i.e. no overnight stay required).

In special circumstances an overnight stay may be necessary due to a proven medical condition. When this is the case, the admitting Doctor must certify in writing what the special circumstances are and why it would be contrary to accepted medical practice, to provide the procedure to the patient. Unless the patient is given treatment at the hospital for a period of time that includes part of an overnight stay.

The below is a non-exhaustive list of **rejected reasons** for an overnight stay for a Type B procedure, as these are not deemed to be Medical Reasons:

- A patient being admitted as they are not from the local Sydney area, e.g. greater NSW, regional, interstate or international.
- A patient being admitted for tests such as imaging, pathology, ECGs, stress tests or other investigations that could be carried out in an outpatient setting.
- A patient's social issues such as living alone or their age demographic.

If there is a requirement for you to stay overnight for medical reason, St Vincents Private Hospital Sydney will require a *Type B Certificate to be submitted from your Doctor* at the time of your hospital booking. This certificate will then be sent to your Healthfund shortly after your have been discharged from hospital.

Your Healthfund will then determine whether the medical condition outlined in this Type B certificate meets their requirements for an overnight stay under the Type B procedure Rules. They will then pay accordingly.

If the Healthfund reject the claim made in the Type B certificate, there can be an unexpected Patient "Out of Pocket" expense that we would like to bring to your attention.

Should your Healthfund makes a rejection for a medical treatment provided in a hospital setting and you believe that this is covered by your health insurance policy or there are unexpected out-of-pocket costs, you can refer the matter to the Private Health Insurance Ombudsman (PHIO) for further investigation on **1300 362 072** or at phio.info@ombudsman.gov.au.
